Business Start-Up

This guide will help you decide whether Business Start-Up is right for you. It gives you all the essential information you need about the course and studying with NEC. You can also speak to our friendly team (details at the end of this guide) who can advise you.

About this course

This course is ideal if you're considering setting up your own small business. You will be guided, step-by-step, through everything you will need to know to plan and establish your business.

Making the decision to become self-employed and to start your own small business is a huge step. You may be thinking about going down this route for one of any number of possible reasons and you may be wondering how best to go about it. This Business Start-Up course will help you through all the stages you need to think about in finding opportunities and getting a business started.

The DVD that comes with the course includes video clips of conversations with four different small-business owners.

Business Start-up consists of two shorter courses which can be taken together or separately:

■ **Course 1: Planning to start your own business:**

The first course will take you through the first steps of identifying if self-employment is right for you, what your business idea is and what are the basic things you need to do to get the business off the ground. By the end of this first course you will have a fully developed business plan.

■ **Course 2: Succeeding with your own business:**

The second course covers the range of activities required to keep your business running in the early stages, including sorting out the legal and financial issues and developing a solid customer base.

To help you understand how to turn your business idea into a reality, both courses include four examples of real-life case studies – a caterer, a fruit and veg supplier, a cleaner and a personal trainer. In addition, the courses also include two fictional case studies – a gardening business and a painting and decorating business – to provide further examples of the type of activities (with examples of documents) that a typical small business will need.

What's included with the course?

When you enrol you will receive the following:

- access to *learn@nec* website
- online access to course materials which you can download and print or study on screen
- tuition from your personal tutor for up to six months
- a free e-book version of any essential textbook(s) where possible
- supporting materials including a Time Planner to help you plan your study timetable and information which explains how to enter for exams

What's not included?

- exam fees where exam(s) or assessed coursework are necessary

Your goals and this course

Before deciding to enrol on this course, think about what you want to achieve. For example, you may want to:

- decide whether self-employment is right for you
- develop your personal skills in being able to identify a good business opportunity
- find out if you have a business idea that offers a product or service that people want.

It's important to check that this course will help you to achieve your goals. This course aims to help you to weigh up the advantages and potential disadvantages of being self-employed. It is important to make an informed decision about a new venture so that you are as clear as you can be about the benefits and the risks.

Course materials

All of our course materials are written and selected by subject matter experts, including experienced teachers, examiners and authors. So you can be confident that the course covers what you need to learn if you are thinking of self-employment or starting your own business.

The course materials are designed to provide a clear guide to your work through the course. The complete course includes nine progress checks. Five in Course 1 and four in Course 2.

Course overview

Specification

There is no specification, but this course will introduce the key stages of business start-up.

Entry requirements

There are no formal entry requirements, but it is recommended that you have the ability to read and write English effectively.

Completion time

As a guideline, you should allow for around 30 hours' study time, plus additional time for completing progress checks. You will have tutor support for the following periods from the date of enrolment:

- Business Start-up (Course 1 + Course 2) – 6 months
- Course 1 – 3 months
- Course 2 – 3 months

Essential textbooks

This course is entirely self-contained and there are no essential textbooks.

Assessment

Five progress checks in Course 1 and four progress checks in Course 2, for a total of nine if the full course is completed. Successful completion of all progress checks will result in an NEC Certificate of Completion.

You can enrol at any time.
